AVI50219 Diploma of Aviation (Commercial Pilot Licence - Aeroplane)

AVI50219 - Diploma of Aviation (Commercial Pilot Licence - Aeroplane) is registered and nationally recognised training by the Australian Skills and Quality Authority (ASQA) and The Civil Aviation Safety Authority (CASA). This diploma authorises you to conduct both private and commercial operations under the Visual Flight Rules (VFR). This licence also allows you to co-pilot in any aeroplane and become the pilot-in-command for aeroplanes under 5,700 Kg.



DURATION AND HOURS

AVI50219 - Diploma of Aviation (Commercial Pilot Licence - Aeroplane) - This course is delivered over 42 weeks with a minimum face to face classroom instruction time of 20 hours per week over a five day week. The course includes 170 hours of single engine dual (70) flying instruction and solo flight (100), plus 30 hours of dual multi engine flying instruction and 15 hours of dual synthetic flight training. Plus face to face theory instruction for all subjects for the CASA examinations.



Delivery

Aviation Theory Training: face to face classroom instructions

Practical Flight Training: with CASA approved flight instructors in aeroplanes and synthetic flight trainers.

Entry requirements

The Civil Aviation Safety Authority (CASA) provides a fair, effective and efficient aviation safety regulatory structure and promotes a positive safety culture throughout the aviation community. To become a student pilot at Professional Pilot Training you must meet the following requirements:

- For international students - an IELTS of 5.5. For more information visit: www.ielts.org or <https://www.casa.gov.au/>.
- For Australia - PPT can conduct a CASA English language proficiency test at an additional cost. Certified copies of results are required with your application.
- Pass a Class 1 Aviation Medical Examination conducted by a Designated Aviation Medical Examiner (DAME) appointed by the Australian Civil Aviation Safety Authority (CASA) prior to course commencement. See the links to the CASA web on our web site at www.professionalpilottraining.com.au.
- A minimum age of 18 years at the commencement of training. We cannot support you as required under Australian Laws if you are younger than this.
- An Aviation Reference Number (ARN) issued by the CASA. PPT will assist with the application.
- A minimum of a secondary school education to the New South Wales (NSW) year 12 standard or its equivalent – unless you are a mature age entrant.
- Hold an Australian Federal Police security clearance for the Australian Securities Identification Card (ASIC). PPT will assist with the application.
- Pass the selection of an Electronic Aptitude Test known as the Electronic Aptitude Test (EAT), before being offered a place on courses.
- Consent to mandatory random drug and alcohol test. Under the **CASR Part 99 - Drug and Alcohol Management Plans (DAMPs) and Testing legislation**.

Assessments

Assessments for **AVI50219 - Diploma of Aviation (Commercial Pilot Licence - Aeroplane)** is divided into four phases and includes several licences, ratings and flight activities that are organised into an integrated holistic training package. A student may complete only some of the phases and finish with a limited set of qualifications.

Formative assessments are completed at regular intervals however because of the holistic nature of piloting the flight test for a qualification is a summative assessment and the units of the qualification are only assessed as competent after passing the flight test for the qualification.

For the final assessment students will be tested for the Australian Commercial Pilot License – CPL which is issued by the Australian Civil Aviation Safety Authority (CASA) and the AVI50215 Diploma of Aviation (Commercial Pilot Licence - Aeroplane). After passing you will be qualified and appropriately skilled to apply for employment as a commercial pilot.



Course Fees

Electronic Aptitude Test

If your application is successful you will be asked to participate in our electronic aptitude test that has also been used in the selection process of commercial and military pilots. It measures situation awareness and stress tolerance, recording components of; Mind-Eye-Hand Coordination, Spatial Orientation, Logical Thinking, Multi-tasking, Short Term Memory and English Comprehension. The EAT achieves a ninety six percent (96%) accuracy in predicting an adult person's aeroplane piloting ability prior to commencing training. The EAT takes 2-3 hours.
